

**Waiver of Liability, Release  
Assumption of Risk & Indemnity Agreement**

**WAIVER: Club or Organization**

**IT IS THE PURPOSE OF THIS AGREEMENT** to exempt, waive and relieve releasees from liability for personal injury, property damage, and wrongful death, including if caused by negligence, including the negligence, if any, of releasees. "Releasees" include Ashland School District, its affiliate associations, other participants, coaches, officials, sponsors, advertisers, owners and operators of the premises used to conduct any event and each of them, their officers, directors, agents and employees. Participant (and participant's parent(s)/guardian(s), if applicable) acknowledge that they have been provided and have read the below paragraphs and have not relied upon any representations of releasees, that they are fully advised of the potential dangers of club sports and understand these waivers and releases are necessary to allow club sports to exist in its present form.

**IT IS AGREED** that for and in consideration of the right and permission to participate in club sports at Ashland High School that the undersigned, for itself, its successors, assigns, officers, directors, agents and employees, hereby, release, remise and forever hold Ashland School District, its successors assigns, agents, employees and all other persons, firms or corporations, who are or might be liable in any way, from any and all liability or responsibility whatsoever of any kind and nature, arising from, and by reason of said participation.

**IT IS FURTHERMORE AGREED** that the undersigned will oversee and be solely responsible for upholding the rules and duties of each club as set forth in the Ashland High School Club Handbook and by Ashland School District. This includes, but is not limited to the verification of Volunteer Driver Insurance requirements, enforcement of specific wishes on Hold Harmless agreements and Clearance of Volunteer Drivers. It is the sole duty of each club to verify that only cleared volunteer drivers are driving students before and after each practice and/or event.

The undersigned do further agree to indemnify and hold harmless the **ASHLAND SCHOOL DISTRICT** and the other above named individuals from any such claims asserted.

The undersigned have read the foregoing Waiver and understand the same fully and sign the same as my voluntary act and deed.
